

Current Series Information

Exodus the second Book of the Bible includes 40 chapters and 1,213 verses. Exodus means departure. The deliverance of the Israelites from Egyptian bondage (slavery). The introductory chapters portray the oppressive conditions of the Israelites and the birth of Moses, who is a great great grandson of Jacob and great grandson of Joseph.

God utilizes Moses through the last 37 chapters to communicate between (God and Pharaoh) and (God and the Israelites).

Upon reaching the Sinaitic peninsula, God provided 10 laws (commandments) at Mount Sinai along with the instructions to build a tabernacle as a place to worship God. The Israelite people struggled with keeping the 10 laws, just as people do today nearly 3,500 years later. God never abandoned the Israelites.

<u>Approval of Bills and Financial Report</u>: Jason provided all information by email and was also provided in council packet. Discussion was held regarding bills and financial report. Proposed 2025 budget is needed.

Pastoring; Weekly premarital counseling, prep and organization for Wedding on 8/31, 6 nursing home visits, 4 meetings with members, 1 radio interview (Mybridge Ministries).

Secretary Report — Sharon gave her report and has also stayed very busy over the last month. Sharon made packets for each council member for the August meeting that included July 2024 financial report, Pitney Bowes lease contract, meeting agenda, copy of the July church council notes. Marketing; Distributed the July/ August Beacon with Homemade Blessings meal delivery on August 15th. Miscellaneous; Welcome notes sent to Sunday Service Visitors for the 3 Sundays thus far in August. Ordered and received gluten free communion wafers, ordered and received Bible Study materials for September study program, North door replacement began July 23rd, Door hung without hardware.
